Sub: Providing 120 on-board training slots by Andaman Nicobar Administration to Students of IMU Campuses- Obtaining the details of students willing for on-board training for September 2018 and March 2019 – Reg.

Ref: IMU's renewed MoU with A&N Administration dated 08.05.2018.

Sirs,

IMU had signed a MoU with Andaman & Nicobar Administration during the Maritime India Summit 2016 held on 15.04.2016 in Mumbai and renewed the same on 08.05.2018 under which A& N Administration agreed to provide 120 assured on-board training slots to students of IMU Campuses.

As per MoU, on-boarding training to the students of IMU is subject to the following conditions:

 The students will undergo training and also work under the guidance of the Master / Chief Engineer of the vessels and be treated as 'crew' for this purpose. In other words, the students should be made to 'sign on' and 'sign off' on the Articles of the Ship and entries of the training should be made in the Continuous Discharge Certificate (CDC) of the students. The Ship's officers should also endorse the record books of the students such as the Cadet Record Book / Training and Assessment Record (as applicable) as mandated by the SCTW convention.

- The students will not be paid any stipend during the duration of the training. In return, the Andaman & Nicobar Administration will not charge the trainees for 'accommodation'; however, the students will be charged for their messing for the days of their stay on-board the vessels.
- IMU will not collect any fees toward on-board training, and all the
 costs relating to joining and leaving the ship, uniforms and shoes to be
 worn on the ship, messing, etc will have to be borne by the trainees
 themselves.

All 120 seats need to be filled and <u>the placement of students on-board has</u> to be personally overseen by the Director and the Nodal Officer nominated <u>for the same</u>.

The procedure to be adopted for allocating on-board training for this year will be given below:

Andaman & Nicobar Administration will provide 120 assured on-board training slots between <u>September 2018 and March 2019</u> for the students of IMU Campuses @ (i) 40 for DNS; (ii) 40 for B.Sc (Nautical Science) and (iii) 40 for B.Tech (Marine Engineering). IMU will divert unfilled on-board training slots from one Course to another Course based on demand.

- First preference will be given to the students of final Semester of B.Tech (Marine Engineering), B.Sc (Nautical Science) and DNS Programmes subject to fulfilling the following conditions:
 - Students should not have any arrear papers at the end of final semester examinations, which is scheduled to be held during June/July 2018.
 - Students who have not placed in any company.
- If the seats remain vacant, preference will be given to the students of B.Tech (Marine Engineering), B.Sc (Nautical Science) and DNS Programmes from immediate passed out batch i.e. June 2017 (with no arrears) and who have not placed in any company.
- In case of number of students who are willing to go for on-board training and have agreed to the above conditions, is more than the number of allotted training slots for that particular programme, then the allotment will be made based on the order of merit of these students.

This provision of on-board training slot may please be brought to the notice of B.Tech (ME), B.Sc (Nautical Science) and DNS students (present as well as passed out batch) and kindly send the details of students agreeing for conditions stipulated by the A&N Administration for on-board training in the enclosed format on or before **25.07.2018**.

Please note that the tenure/slots of the training is solely at the discretion of Andaman & Nicobar Administration and IMU cannot assure any extra time/seats other than provided by the Andaman & Nicobar Administration.
