1.	Providing, fixing and installation of FRP diving board of size 2' X 10' including with SS Fulcrum to be installed at a height of 2.5m from swimming pool top level. (It shall constructed of a basic ribbed one piece extrusion, heat treated for min. yield strength of 50000 psi of aluminum alloy. The board shall be coated in aqua colored thermal curing epoxy resin. The top surface is coated with three layer of sand & white aluminum oxide to effect slip-resistant surface. The top surface has approx 200 perforations measuring approx. 1.5 inch long & 0.25 inch wide, extending 21 inch back from the tip end of the board)

Eligibility Criteria of the firm:

- a. Bidders should submit a proof (Work Order / Work Completion Certificate) towards successful undertaking of similar work under any Central Govt. / PSU / State Govt. / Private organisation during last 5 years since 2017-18
- b. Bidders should have valid Trade licence for similar work.
- c. The Bidder should have valid GST & PAN.
- d. Bidders have to submit their quotations along with an EMD amounting to Rs. 5,000.00 in the form of Demand Draft drawn on any Nationalized Bank / Scheduled Bank drawn in favour of "Indian Maritime University Kolkata Campus" payable at Kolkata. EMD will be refunded to all the unsuccessful bidders within one month after the completion of our evaluation process. No interest will be allowed on EMD. Quotations without EMD and the documents stated under eligibility criteria will simply be rejected.

Terms & Conditions:

- 1. Bidders should quote their rates in the above format inclusive of all but excluding taxes, which should be stated separately.
- 2. The rates quoted should be valid for two months from the date of issuance of the tender.
- 3. Prospective Bidders may visit the campus at P-19, Taratala Road, Kolkata 700 088 in any working day (Monday to Friday) within 1000 1700 hrs. before submission of their quotations.
- 4. Warranty for a period of 1 year should be provided on the above work.
- 5. Work should be completed within 10 days from the date of the work order, failing which LD @ 0.5% per week or part of the week may be imposed upto a maximum of 10% of the value of the Work Order.
- 6. Submission of multiple bids by a single firm will lead to rejection of the bids and IMU-KC may black list such firms from future participation.
- 7. Last date of submission of quotation is 29.09.2022.
- 8. E-invoicing is mandatory as per Notification No. 61/2020 Central Tax dated 30.07.2020.
- 9. The quotation is to be submitted in sealed envelope clearly subscribing "Quotation for supply and installation of FRP Diving Board for the BST Course at IMU-KC".
- 10. The envelope should be addressed to the Dy. Registrar, Indian Maritime University, P 19, Taratala Road, Kolkata 700 088 and deposited in the Tender Box kept at the Dy. Registrar's office (1st floor, Room No. 130) or can be sent by post.
- 11. The envelopes are to be sealed properly with gum and not by stapler pin.
- 12. Evaluation of the quotations would be done based on the L1 of the rates quoted by the firms.
- 13. Notwithstanding anything specified in this letter inviting quotation, IMU-KC at its sole discretion, unconditionally and without assigning any reason, reserves the right:
 - (a) To accept or reject lowest bid or any other bid or all the bids.
 - (b) To accept any bid in full or in part.
 - (c) To reject the bid offer not conforming to the tender conditions.
- 14. Micro and Small Enterprises should provide valid MSME certificate along with the quotation.
- 15. Payment will be made through Bank Transfer after successful completion of the work.
