- (ii) The rates quoted should be comprehensive and inclusive of all taxes, delivery charges, installation, commissioning and trail run.

- (iv) The Air Conditioner should be delivered and installed within the period of 3 weeks from the date of issue of Purchase Order. If the bidder fails to deliver and/or installation Air Conditioner by the specified date, penalty at the rate of 1 % per week of the total order value subject to the maximum of 10% of total order value will be deducted.
- (v) Delivery of the above items should be made at IMU - Kolkata Campus at P-19, Taratala Road, Kolkata 700 088.
- (vi) Rates quoted should be valid for a period of 2 months from the last date of submission of the bids.
